Sub.: Extension of medical facilities of ICAR-CSWRI human dispensary and institute's empanelled hospitals

This is to bring to your kind notice that I am deprived of medical facilities of ICAR human dispensary located at Avikanagar and institute's empanelled hospitals in Jaipur for OPD with reimbursement of the bills. I would like to submit following points for your consideration please

Sir, consideration please.

- 1. I have given **one time option**, as per the ICAR Circular F.No. 3(1)/93-Per.IV dated 22 January, 1999, to avail facility of ICAR-CSWRI Human Dispensary.
- 2. I am not getting fixed FMA of Rs 1000/- pm .
- 3. My parental home at Malpura near within 5 Km from the Institute. I reside both at Malpura and near city at Jaipur.
- ICAR-CSWRI has approved various hospital in Jaipur for indoor and OPD to in-service employees and pensioners. Pensioners are not getting reimbursement of medicines prescribed in OPD.
- 5. Jaipur city is the nearest city from Avikanagar where Office cum guest house of the institute located. Many ICAR-CSWRI pensioners are settled

in Jaipur and opted to avail medical facility from ICAR-CSWRI dispensary.

- I represented my case to H:ble Secretary, DARE and DG, ICAR through my letter dated 20.08.2021.
- The council vide letter no. F.No. 38(3)2021-Per.IV Dated 08th October,2021 directed to me to submit a formal request in this regard to the Director of the ICAR -CSWRI as per provision made in the Council letter No. 3(3)/2008-Per.IV Dated 13.08.2010.
- 8. It is clearly mentioned that medical facilities of ICAR dispensaries is allowed to pensioners who opted once . For further clarity I hereby reproduce the content of the letter for your refence please.
 Para 1 of the letter provides that the ICAR pensioners shall avail medical facilities to the extent available at the dispensaries at the ICAR Institutes located In and around the place of their settlement. further provides that the pensioners shall get themselves registered with the respective dispensaries of the institutes.

it has been decided that the pensioners may opt for claiming reimbursement from any of the ICAR Institutes located in and around the place of their settlement to ensure speedy disposal of their claims.

Therefore, I humbly request that pensioners settled in the nearby cities, where hospitals are also empanelled by the institutes, they should be allowed to avail OPD facility of ICAR dispensary at par with in-service employees for chronic diseases like Diabetes, blood pressure etc. and cost of medicines may be reimbursed if medicines not available in hospitals /dispensaries.
